BENEFITS OF A BEQUEST TO BIG TABLE

SIMPLE TO DO. Making a bequest is as straightforward as working with your estate planner to insert a few sentences into your will or living trust. This can be changed at any time. There are several types of bequests - *you can learn more about these options and estate planning language associated on the back.*

SPECIFIC BEQUEST - Giving a specific dollar amount, piece of personal property or real estate

RESIDUARY BEQUEST - Gifting the remainder of your estate

GENERAL BEQUEST - An outright gift, usually a sum of money

CONTINGENCY BEQUEST - A gift contingent to an event or outcome

COSTS NOTHING NOW. Making a bequest costs you nothing today. Yet, it gives you the joy of knowing that you have provided lasting support for Big Table care.

CREATES A LASTING LEGACY. Shape the legacy of care for those in need by sharing a planned gift with Big Table - a legacy that will bless others for years to come.

This is a gift through your will or living trust of a certain item to an individual or charitable organization like Big Table. You can change your mind at any time. If you dispose of the item before your death, the bequest is not effective and no claim can be made to any other property. With a gift of a specific item, Big Table reserves the right to maintain and use the property, or sell the item and use the proceeds for our general uses and purposes.

BEQUEST OF SPECIFIC PERSONAL PROPERTY

I hereby give, devise and bequeath [DESCRIPTION OF PROPERTY] to Big Table, a nonprofit organization located at 827 W. First Ave, Suite 425, Spokane, WA 99201 Federal Tax ID #20-8931223, for Big Table's general use and purpose.

BEQUEST OF SPECIFIC REAL ESTATE

I hereby give, devise and bequeath all of the right, title and interest in and to the real estate located at [ADDRESS OR LEGAL DESCRIPTION OF PROPERTY] to Big Table, a nonprofit organization located at 827 W. First Ave, Suite 425, Spokane, WA 99201 Federal Tax ID #20-8931223, for Big Table's general use and purpose.

BEQUEST OF PERCENTAGE AMOUNT

I hereby give, devise and bequeath ___percent (___%) of my total estate, determined as of the date of my death, to Big Table, a nonprofit organization located at 827 W. First Ave, Suite 425, Spokane, WA 99201 Federal Tax ID #20-8931223, for Big Table's general use and purpose.

GENERAL BEQUEST

This is an outright gift and is usually a stated sum of money. It remains effective even if there is not sufficient cash to make the bequest; other estate assets will be sold to provide the bequest you included in your will or living trust.

BEQUEST OF SPECIFIC DOLLAR AMOUNT

I hereby give, devise and bequeath _____ and No/100 dollars (\$DOLLARS) to Big Table, a nonprofit organization located at 827 W. First Ave, Suite 425, Spokane, WA 99201, Federal Tax ID #20-8931223, for Big Table's general use and purpose.

RESIDUARY BEQUEST

This is an outright bequest of all or a portion of the "rest, residue and remainder" of your estate after all other specific or general bequests, debts and taxes have been paid. Divide your estate according to percentages of the residue you choose to ensure that beneficiaries receive the proportions you desire.

I hereby give devise and bequeath to Big Table, a nonprofit organization located at 827 W. First Ave, Suite 425, Spokane, WA 99201 Federal Tax ID #20-8931223, [ALL OR A PERCENTAGE] of the rest, residue and remainder of my estate to be used for Big Table's general use and purpose.

CONTINGENT BEQUEST

This is a bequest made on the condition that a certain event must occur before distribution to the beneficiary. This bequest is specific in nature and is not effective if the condition is not met.

If [PRIMARY BENEFICIARY/BENEFICIARIES] does/do not survive me, then I hereby give, devise and bequeath to Big Table, a nonprofit organization located at 827 W. First Ave, Suite 425, Spokane, WA 99201 Federal Tax ID #20-8931223, [DESCRIPTION OF PROPERTY], to be used for Big Table's general use and purpose.
